President Dan Vander Wal called this special board meeting to order at 6:45 PM.

Robert (Rob) Parnell was asked for what his outsider view of TRHOA is and what his plans are if he would be president of the Association.

Rob moved to TR 3 ½ years ago. He has 3 children and lives at 156th and Manion. Asked about what the view is of TRHOA from the outside, he stated one does not know what is going on in the neighborhood and what the Association is doing for it. His plans are to work on communicating through quarterly mailings, keeping the web site up-to-date, and providing a neighborhood directory. The by-laws should be updated to reflect the fact that the developer, John Buchan, is no longer running the Association. On the trailer parking issue, he stated that the rules should be enforced.

Roger Porter was given the opportunity to respond to the same questions. Roger has lived in TR for 3 years and has lived in Duvall for 10 years. He has been involved in the Duvall Hills Homeowners Association as Vice President. Roger works at Microsoft. He stated that TRHOA is not a communicator, there is no welcoming person, visibility is lacking, and follow through is needed. Habitual offenders of the CC&Rs need to be called on their offences. Questioned on how to get more people to volunteer, his answer was to ask people for their help. He also suggested it would be important to stick to an agenda for the annual meeting without becoming too formal.
