Election of Officers

Enforcement of CCR's

The discussion covered which situations may constitute an infraction and what action the homeowners expect the Board to take. Options range from do nothing, to enforce a remedy and cover the expenses by a lien on the property. Input from the surrounding neighbors of an offending homeowner was expressed to be an important element in deciding what action to take. This subject was raised at the annual meeting and the Board was directed to develop Rules and Regulations.

Secretary duties

Chris should take over maintenance of the membership list and future mailings.

When to Use an Attorney?

The possibility of adopting more rigid past due assessment rules was discussed in the Annual Meeting. The necessity to get an attorney involved was considered. The need to search for an attorney was discussed. The Board will search the Wash. Bar Assoc. and other HOA's.
